2. *Company Registration certificate*
3. *Identity documents of members or Shareholders*
4. *Company Profile*
5. *Valid TAX Clearance certificate /or Tax Pin.*
6. *BBBEE Certificate or Sworn Affidavit*
7. *Curriculum Vitae and Qualification for Members and/or Key Personnel*
8. *Letter of Authority of Signatory*
9. *Proof of ownership of plant (for plant suppliers only)*
10. *THLM Proof of residence or Utility account Statement*

#### Stage 2: The Pricing stage which will be for the pricing the Bill of Quantities:

*For responsive bidders to be considered, they must have satisfied/met the requirement of stage 1. Therefore further correspondence will be done with the shortlisted bidders who met Pre-evaluation qualification ONLY.*

A 60:40 ratio will be used for the selection of proposals, with

- 60% preference allocated to the business located in the ward whereby the project is being implemented.
- 40% allocated to locals within other areas of Thembisile Hani Local Municipality.
